PRIVACY POLICY

7k Metals, LLC (referred to herein as “7k Metals”, “our”, “us” or “we”) is committed to respecting the privacy rights of those visiting our websites, apps, or using the 7k services provided to 7k customers, Members, and Associates, including 7k Associates' Replicated Websites (hereafter collectively referred to as the “7k Services”). 7k provides this Policy as notice of how 7k may collect, use, share, and keep information about you, and to inform you of your choices and privacy rights concerning the use of any personal information collected by 7k.

By visiting 7k Websites or using 7k Services, you agree, without limitation or qualification, to be bound by this Privacy Policy, and you are accepting the practices described in this Privacy Policy. When you provide information to 7k or by using the 7k Services, you are consenting to the manner in which 7k Metals will collect, use, disclose, and otherwise manage your Personal Information, as set out below. This Privacy Policy is only applicable to 7k, its Websites, and related 7k Services, and it does not apply to any Third-Party websites, which may have data collection, storage and use practices and policies that differ materially from this Privacy Policy. *No mobile opt-in data will be shared with third parties.* For additional information, see the section concerning Third-Party Websites, below. Each time you use the 7k Services, the then-current version of this Privacy Policy will apply. Accordingly, each time you use any 7k Services, you should check the date of this Privacy Policy and review any changes since the last time you visited the 7k Website or used the 7k Services. For additional information, see the section concerning Updates and Changes to Privacy Policy, below.

1. SUMMARY

Generally speaking, 7k Metals collects the information you provide to 7k when making an order, purchasing a customer membership, or applying to become a 7k Associate, which may include your name, address, email address, phone number, bank account information, order or commission history, and notes from customer service calls. 7k or its affiliates and contracted service providers may also collect your date of birth, tax ID, government ID, or other information necessary to complete legally required Know-Your-Customer diligence and comply with legal or tax reporting obligations. Additionally, 7k's website may collect, track, and use your information incidental to use of the 7k Services, including Traffic Data (e.g., IP address including geolocation data), Cookies, and information you provide through forms on 7k's website.

7k does not sell your Personal Information to third parties. 7k uses your Personal Information exclusively to facilitate and provide or improve 7k Services, to fulfill the purchase and delivery of 7k products, and to comply with 7k's tax and legal obligations, consistent with customary business practices. 7k may share your Personal Information with its affiliates, Associates, or trusted service providers, but only to the extent reasonably necessary or helpful to provide the 7k Services and meet its legal and business obligations.

CONSISTENT WITH THESE SEPARATE AGREEMENTS, YOU WAIVE ALL RIGHTS TO TRIAL BY JURY OR TO ANY COURT AND ANY CLAIM OR COUNTERCLAIM FILED AGAINST 7K METALS SHALL BE FILED ONLY ON AN INDIVIDUAL BASIS AND NOT WITH ANY OTHER PARTY OR AS PART OF A CLASS ACTION OR REPRESENTATIVE ACTION OR AS A PRIVATE ATTORNEY GENERAL.

BY USING THE WEBSITE, YOU REPRESENT AND WARRANT THAT YOU HAVE READ AND UNDERSTOOD, AND AGREE TO THE TERMS OF, THIS PRIVACY POLICY. IF YOU DO NOT UNDERSTAND OR DO NOT AGREE TO BE BOUND BY THIS PRIVACY POLICY, YOU MUST IMMEDIATELY LEAVE THE WEBSITE AND NOT USE THE 7K SERVICES.

2. WHO MAY USE THE 7K SERVICES

A. Children's Privacy. 7k Metals is committed to the safety of children. 7K Services are not intended or designed to attract users under the age of 18. Persons under the age of 18 may not enroll as 7k Metals Associates or register as Customers. Children under the age of 13 may not use or purchase products through any of 7k Services. 7k Metals does not solicit or knowingly collect personally identifiable information from children under the age of 13. If 7k Metals obtains actual knowledge that it has collected personally identifiable information from a child under the age of 13, 7k Metals will immediately delete such information from its database. Because 7k Metals does not collect information from children under the age of 13, 7k Metals has no such information to use or disclose to third parties. 7k Metals has designed this Privacy Policy in order to comply with the Children's Online Privacy Act (COPA).

B. Users Outside Of the United States. The 7k Services are intended for users from the United States, consistent with data protection laws of other countries in which 7k Metals is authorized to do business. Users from the European Union are advised not to disclose Personal Information to 7k Metals. Information sent to 7k is housed on servers located in the State of Idaho in the United States. Do not send us information unless you consent to the application of U.S. law and to the use and disclosure of your information consistent with this Privacy Policy.

3. INFORMATION COLLECTION

7k Metals is the owner or authorized licensee of the 7k Services. 7k collects information from visitors to its Websites, from its customers, and from independent 7k marketing Associates ("Associates") at different points on its websites and when facilitating the use of 7k Services.

A. Traffic Data. Like most website operators, 7k Metals may automatically gather information of the sort that Internet web browsers automatically make available, including: (i) IP addresses; (ii) geolocation information, (iii) domain servers; (iv) types of devices accessing the Website; and (v) types of Web browsers accessing the Website (collectively "Traffic Data"). Traffic Data is anonymous information that does not personally identify you.

B. Cookies. A "Cookie" is a string of information that a website stores on a user's computer, and that the user's browser provides to the website each time the user submits a query to the website. The purpose of a Cookie is to identify the user as a unique user of the Website. 7k Metals uses Cookies to customize your experience on the Website to your interests, to ensure that you do not see the same informational messages repeatedly, and to store your username so you do not have to re-enter it each time you visit the Website. For additional information on 7k Metals' use of Cookies, see the section concerning Information Use and Disclosure Practices/Traffic Data and Information Gathered Using Cookies, below.

C. IF YOU DO NOT WISH TO HAVE COOKIES PLACED ON YOUR COMPUTER, YOU SHOULD SET YOUR BROWSERS TO REFUSE COOKIES BEFORE ACCESSING THE WEBSITE, WITH THE UNDERSTANDING THAT CERTAIN OF THE SERVICES AND CERTAIN FEATURES OF THE WEBSITE MAY NOT FUNCTION PROPERLY WITHOUT THE AID OF COOKIES. IF YOU REFUSE COOKIES, YOU ASSUME ALL RESPONSIBILITY FOR ANY RESULTING LOSS OF FUNCTIONALITY.

D. Personal Information. Through your use of 7k Services or visits to 7k Websites, you may be required or requested to provide personally identifiable information (hereafter "Personal Information") to 7k or its affiliates. Personal Information is any piece of information which can potentially be used to uniquely identify, contact, or locate a single person. Such information includes, without limitation: (1) "Contact Data" (such as your name, mailing address and e-mail address); (2) "Demographic Data" (such as your age, gender, profession, education level, relationship status, religious affiliation, country, state, city and likes and dislikes,); and (3) "Financial Data" (such as your credit/debit card number and expiration date). For certain transactions, we may be required to collect additional information to comply with legal requirements. In each case, you will be asked to provide Personal Information; the Website will not gather it surreptitiously. 7k Metals may supplement the Personal Information you provide with additional personal information gathered from public sources or from third parties (e.g., consumer reporting agencies) who may lawfully provide such information to 7k Metals. You are under no obligation to provide Personal Information, with the caveat that your refusal to do so may prevent you from using 7k Services or certain of the features and services available on the Website or when purchasing any of 7k's products.

E. Non-Personal Information. "Non-Personal Information" is anonymous information that 7k may collect that is not traceable to any individual person or computer. 7k utilizes this data to analyze trends and understand customer needs while shopping and interacting on our site so that we can provide a better user experience. For example, we may use cookies, web beacons, log files and other technologies to collect information about visitors to our Website, and interactions with our online advertisements and offerings.

F. Associate Registration. In order to become an Associate, an applicant must provide Personal Information to us. We also may require an applicant's tax identification number (e.g., Social Security Number or Federal

Tax ID Number) so that we may prepare and file necessary non-employee compensation forms for the IRS, or similar reporting documents. Certain customers may be required to register in order to purchase products directly from us ("Preferred Customers" or "Direct Customers," both of which are collectively referred to herein as "Customers"). Customers will be required to provide Personal Information. We use this information to maintain contact with Associates and Customers, and to process Associate and Customer orders.

G. Product or Service Purchases. When a customer or Member (preferred customer) purchases products or services from us through any of our Websites, the purchaser must provide us with Personal Information. This information is used for billing and payment purposes and for all orders.

H. Information that you make Public. The 7k Services may contain features (e.g., public profiles, forums, and message boards) that permit you to upload, post, transmit, display, perform or distribute content, information, or other material, including some of your Personal Information. Any information that you choose to disclose by means of such features becomes public information over which 7k Metals is unable to exercise control. You should exercise caution when deciding to disclose your Personal Information by means of such features, and you agree to assume all responsibility for doing so.

I. Information Obtained From Third Party Sources. We may receive information about you such as contact information and demographics information from other sources. In addition, we may combine the information you give us with information from these sources. The types of information and sources of such information include without limitation the following categories:

- i. Vendors.** We may receive contact information and demographic information that you provide to or through our vendors, such as through our email and text message campaigns.
- ii. Your 7k Associate Sponsor (if applicable).** Information such as account or demographic information that is submitted by your 7k Associate Sponsor on your behalf.
- iii. Payment Service Providers.** Payment information such as updated credit card tokens and expiration dates from your bank or credit card company which we use to keep our records current and service you better.
- iv. Delivery Service Providers.** Delivery details such as updated delivery, contact information, and address information from our carriers or other third parties which we use to keep our records current, process orders, deliver your next purchase, and service you better.
- v. Social Media Services.** Information that you publicly post on our and your social media pages (e.g., our Facebook®, Instagram®, and Twitter® pages), such as your contact and demographic information, such as likes, interests, preferences, comments, suggestions, and opinions, general feedback, and content.
- vi. Other Third-Party Sources (Including Data Aggregators and Public Databases).** Transactional data from third party purchases; contact information, demographics information, including profile data; information about products or services purchased from other companies.

4. INFORMATION USE AND DISCLOSURE PRACTICES

A. Traffic Data and Information Gathered Using Cookies. We use "cookies" to recognize you as you use or return to our sites. This is done so that we can provide a continuous and more personalized shopping experience for you. A cookie is a small text file that a website or email may save to your browser and store on your hard drive. Most cookies are "session cookies," meaning that they are automatically deleted from your hard drive once you sign out from 7kmetals.com or close your web browser. We use cookies to provide features and services, such as:

- i.** allowing you to enter your password less frequently;
- ii.** remembering your preferences;
- iii.** presenting information that is targeted to your interests;
- iv.** measuring the effectiveness of our sites, services, content, and advertising; and providing other services and features that are available only through the use of cookies.

7k Metals analyzes Traffic Data and information gathered using Cookies to help 7k Metals better understand who is using the 7k Services and how they are using it. By identifying patterns and trends in usage, 7k Metals is able to better design the 7k Services to improve your experience, and to serve you more relevant and interesting content. From time to time, 7k Metals may release Traffic Data and information gathered using Cookies in the aggregate, such as by publishing a report on trends in the usage of the 7k Services. 7k Metals does not attempt to link information gathered using Cookies to Personal Information.

B. Web Beacons. We may also use web beacons. A "web beacon" is an electronic image placed in the code of a web page. Beacons allow us to know if a certain page was visited, an email was opened, or if ad banners on our website and other sites were effective. We use web beacons to monitor the traffic patterns of users from one page to another and to improve site performance.

C. Personal Information. Personal Information that is collected from retail customers, Members, and Associates through customer registration, Member enrollment, or the Associate application process, on the

purchase of 7k products or services, and in connection with Surveys are used and disclosed as described in this Privacy Policy. Except as specifically set forth in this Privacy Policy, 7k Metals DOES NOT sell or share Personal Information. 7k Metals may share aggregated information from time to time with its partners, vendors or other third parties. When such aggregate information is shared by 7k Metals, no Personal Information is shared.

D. Disclosure Practices. Except under the following circumstances and otherwise as set forth in this Privacy Policy, 7k Metals will keep your Personal Information private and will not sell it to or share it with third parties.

i. Mobile Information. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. 7k Metals uses mobile information solely to facilitate the provision of 7k Services, send communications regarding product orders, verify customer identity, authenticate account access, and to communicate important information about your 7k accounts or Services. All the categories identified in Section 3 exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

ii. Disclosure in Connection with Services. Some of our operations, such as our electronic commerce, may be managed by Service Providers who are unaffiliated companies. These companies may share Personal Information with their affiliates and service providers whom they engage to perform services related to our Websites or the operation of our business. Examples of these services include payment processing and authorization, fraud protection and credit risk reduction, product customization, order fulfillment and shipping, marketing and promotional material distribution, Website hosting and evaluation, data storage, analysis, or security and, where applicable, data cleansing. These companies may have access to your Personal Information on a confidential basis only to the extent necessary to perform their functions. In no event will we authorize these companies to use your Personal Information for any reason other than to provide you with those specific services. If your purchases are being shipped to you, your shipping information will be shared with our delivery service providers (U.S. Postal Service, UPS, FedEx, or other delivery companies we or you select). Our delivery service providers are asked not to use your Personal Information for any purpose other than making the delivery.

iii. By Law or to Protect Rights. 7k Metals discloses Personal Information when required to do so by law, or in response to a subpoena or court order, or when 7k Metals believes in its sole discretion that disclosure is reasonably necessary to protect the property or rights of 7k Metals, third parties, or the public at large.

iv. Legally Required Law Enforcement, Judicial and Administrative Agency Disclosures. 7k Metals will provide confidential and personally identifiable information as necessary to comply with judicial and administrative orders, subpoenas, Civil or Criminal Investigative Demands, Administrative and Regulatory Demands and other legal obligations. In order for 7k Metals to conduct business in certain jurisdictions, 7k Metals must disclose certain personally identifiable and confidential information to regulatory authorities in such jurisdictions. Such information may include, but is not limited to, income information and personally identifiable information.

v. Business Transfers; Bankruptcy. 7k Metals reserves the right to transfer all Personal Information in its possession to a successor organization in the event of a merger, acquisition, or bankruptcy or other sale of all or a portion of 7k Metal's assets. Other than to the extent ordered by a bankruptcy or other court, the use and disclosure of all transferred Personal Information will be subject to this Privacy Policy, or to a new privacy policy if you are given notice of that new privacy policy and an opportunity to affirmatively opt-out of it. Personal Information submitted or collected after a transfer, however, may be subject to a new privacy policy adopted by a 7k Metals successor organization.

vi. Unpaid Accounts. If you fail to pay any balance owed in consideration of Services, 7k Metals may, as permitted by law, report your Personal Information, including without limitation your unpaid balance, to consumer credit reporting services, collection agencies and others.

vii. In Connection with Network Marketing. To help Associates in the 7k Metals network marketing program manage their independent businesses, we may provide your 7k Metals enroller and potentially other upline 7k Metals Associates with your name, rank, address, telephone number, and email address as well as data relating to your sales and enrollment activity through a secure portal in the 7k BackOffice to the Website. We also provide downline Associates with the names, rank, address, telephone number, and email address of their upline sponsor and certain upline Associates in the Support Team.

5. COMMUNICATIONS FROM US

A. Special Offers and Updates. By registering as a customer, purchasing a customer Membership, enrolling as an Associate, or making a purchase or other inquiry through any 7k Service, you consent to receive periodic email and other communications from us and from 7k Metals Associates. For example, 7k Metals sends all new Associates and Customers a welcome email to verify password, username, and acceptance of the

Associate Agreement, as well as other inquiries to verify your identity in connection with 7k's anti-money laundering program. All Associates and Customers will occasionally receive information on products, services, special deals, and a newsletter.

B. Service Announcements. On rare occasions it is necessary to send out purely service-related communications. For instance, if 7k Services become temporarily unavailable or suspended for maintenance or due to technical difficulties, we might send an email or SMS text message. Generally, Associates may not opt-out of these communications, though they can deactivate or cancel their account. However, these communications are not promotional in nature.

C. Member Support. 7k Metals communicates with its customers, Members, and Associates via email, text messages, regular mail, and telephone on a regular basis to provide requested services, fulfil product orders, and in regard to the management of their 7k Metals businesses. Such communications may be by email, regular mail, text message, or telephone.

D. Privacy Preferences/Opt-Out. We now offer an on-line preference page located within the My Account section on www.7kmetals.com BackOffice where you can register and change your preferences about receiving or not receiving marketing or promotional materials. You may also update what product/lifestyle preferences you prefer, which may determine what offers and promotional materials you may receive. You may update these preferences at any time, but you must first register by creating an account before you can update any of your preferences. Please allow sufficient time for your preferences to be processed. You may also change your marketing preferences or remove yourself from our mailing list by clicking on an "unsubscribe" hyperlink contained in promotional emails we send you or by contacting us at: 7k Metals, Member Support, 3640 S. Yellowstone Ave., Idaho Falls, Idaho 83402, Attn: Privacy Manager or by e-mailing privacy@7kmetals.com.

6. MISCELLANEOUS

A. Links. The 7k Metals websites and Services may contain or present links to other sites. 7k Metals is not responsible for the privacy practices of such other sites. We encourage users to be aware when they leave our site and to read the privacy statements of each and every website that collects Personal Information. This privacy statement applies solely to information collected by 7k Metals websites and 7k Services.

B. Security of Personal Information. 7k Metals maintains administrative, technical, and physical safeguards to protect against unauthorized access, use, modification and disclosure of Personal Information in our custody and control. We are committed to using technology to protect the security of 7k Services and your Personal Information. However, even with the best technology, no website or service is 100% secure. We will take reasonable measures that we believe appropriate to protect your Personal Information from loss, misuse, alteration, or destruction, and, where possible, will ask that any third to whom we may transfer such information to take comparable steps to protect that security.

C. Secure Shopping. When you place an order through 7k Services, all of your order information, including your debit/credit card number and delivery address, is transmitted through the Internet using Secure Sockets Layer (SSL) technology. SSL technology causes your browser to encrypt your order information before transmitting it to our secure server. SSL technology, an industry standard, is designed to prevent someone other than the operators of the 7k Services from capturing and viewing your Personal Information. Since any order information you provide to us will be transmitted using a secure connection, if your Web browser cannot support this level of security, you will not be able to order products through our Websites. The most recent versions of Google Chrome, Netscape Navigator, Apple Safari, and Microsoft Internet Explorer can support a secure connection and can be downloaded for free from the Google, Netscape, Apple, or Microsoft website respectively. 7k Metals does not store your credit card information.

D. Passwords. To provide you with an increased level of security, online access to your Personal Information is protected with a password you select. We strongly recommend that you do not disclose your password to anyone. 7k Metals will never ask you for your password in any unsolicited communication (including unsolicited correspondence such as letters, phone calls or e-mail messages).

E. Lost or Stolen Information. You must promptly notify us if your credit, banking, other financial information, username or password is lost, stolen, or used without permission. In such an event, we will remove that credit card number, bank account information, other financial institution information, username, or password from your account.

F. Promotional Activities. From time to time, 7k Metals may conduct contests, giveaways, and other promotions (collectively, "Promotional Activities"). Any information submitted in connection with Promotional Activities will be treated in accordance with this Privacy Policy. From time to time, 7k Metals may also ask you to participate in surveys designed to help 7k Metals improve the Websites, its products, services, or the 7k Metals network marketing program. Any Personal Information provided to 7k Metals in connection with any survey will be used only in relation to that survey and will be disclosed to third parties not bound by this Privacy Policy only in aggregated form.

G. Changes to this Privacy Policy. 7k Metals reserves the right to amend or change this Privacy Policy at any time at its sole discretion. It is your responsibility to periodically access this Privacy Policy by clicking on the Privacy Policy link at our home page. You can determine the date this Privacy Policy was last updated by referring to the effective date found at the end of the policy. When material changes or amendments are made to the Privacy Policy, we will publish the amended Privacy Policy on our website at www.7kmetals.com, and you may cancel your account at any time if you disagree with such amendments.

H. Making Changes to Your Personal Information. Associates and Customers may update their personal information as necessary by logging into their 7k Metals online Back Offices, which allows them to access and edit their registration account information. In addition, Associates and Customers may contact us at support@7kmetals.com to update their profiles.

I. Information Sharing Disclosure Requests. If you are a California resident, you have the right to request one Notice of Information-Sharing Disclosure per year which will identify the third parties with whom 7k Metals or any of our affiliates has shared the Personal Information we have collected from you. You may request the Notice of Information-Sharing Disclosure by writing to us at: 7k Metals, 3640 S. Yellowstone Hwy, Idaho Falls, Idaho 83402, Attn: Privacy Manager or by e-mailing privacy@7kmetals.com. We will respond to your request for a Notice of Information-Sharing Disclosure within 30 days.

K. Effective Date. The effective date of this Privacy Policy is October 15, 2016

7. DISPUTE RESOLUTION

This Privacy Policy is governed by the laws of the State of Idaho. The use of 7k Services or the 7k Websites shall occur in Bonneville County, State of Idaho. Any dispute arising from or relating to this Privacy Policy shall be brought solely in the courts of the State of Idaho in and for Bonneville County. Each party to a dispute arising from or relating to this privacy policy shall bear his/her/its own attorney's fees, costs, and expenses. If a visitor to this site wishes to bring an action for the breach of this privacy policy, he/she shall do so on an individual basis and not as part of a class or in any representative capacity, including as a Private Attorney General. Visitors waive all rights to bring an action on a class or consolidated basis. If a visitor to this site is also a 7k Member or 7k Associate and combines claims under this privacy policy with claims that are subject to 7k's Customer/Member Privileges & Conditions, the 7k Associate Agreement, or the 7k Policies & Procedures, the dispute resolution provisions of such 7k agreements shall govern, which each include an obligation to resolve all disputes in binding arbitration on an individual basis.

8. NOTICE TO CALIFORNIA RESIDENTS

A. Your Privacy Rights. Residents of the State of California (under California Civil Code Section 1798.83) have the right to request from companies conducting business in California a list of all third parties, if any, to which the company has disclosed personal information during the preceding year for direct marketing purposes (e.g., requests made in 2019 will receive information about 2018 sharing activities). B. California Consumer Privacy Act Notice. Residents of California have certain rights with respect to their Personal Information.

- i. We do not sell your Personal Information to any third party or parties. Although we do not sell your Personal Information to any third parties, you have the right to request that we not sell your Personal Information. To make this request email privacy@7kmetals.com or click on the link in the footer of our website.
- ii. You have the right to request that we disclose to you the specific items of Personal Information that we have collected about you. To request such information, submit a request to us at . You will be required to verify your identity. Upon receipt of your request and verification of your identity, we will provide you with all the information that we have that is responsive to your request. Such information will be provided to you at no charge to you and within 45 days of your request.
- iii. You have the right to request that we permanently delete your Personal Information from our records. To request that your Personal Information be deleted from our records, submit your
